TERMS AND CONDITIONS:

1. No booking can be made unless we have a "fully completed booking form" and a deposit paid of R2000.00. We do not do provisional bookings.
2. Only duly authorised signatures may sign the booking sheet.
3. Payment terms: strictly 50%, 7 days prior upon confirmation of final number of golfers. Failure to make this payment will result in cancellation of the golf day, balance due on presentation of invoice.
4. Any decrease in the number of golfers within the 7 days prior period; will still be charged for.
5. All drinks are for your own account unless otherwise agreed upon in writing.
6. KDMGC reserves the right to make changes to tee times / tees providing you are notified 7 days prior.
7. We only do shotgun starts by special request and this carries an additional cost.
8. Advertising and external branding may be put up only 1 hour prior to the event and must be removed directly afterwards.
9. Cancellation terms are 7 days prior – thereafter no refund will be issued and you will be liable for full total.
10. We will not be held liable for any loss, damage of décor, equipment or clubs left on the premises.
11. In the event of the catering not being able to be served at the stipulated serving times, due to reasons outside of the clubs control; we will not be held liable for spoiled food. We will endeavour to ensure the food is kept warm and fresh to the best of our ability.
12. Right of admission is reserved.
13. We do not serve strictly Halaal and Kosher meals.
14. We do not allow external catering except in the case of requiring strictly Halaal or Kosher foods. Only pre- approved suppliers may be used and a surcharge of R10 – R20 per person will be levied.
15. Members of Club will receive a 10% discount on catering and bar purchases, only if it is paid by using there pre-paid membership card.
16. No privately printed HWH or meal vouchers will be accepted as a form of payment. Only club vouchers can be used which have been pre-paid for.
17. As we do not charge a fee for wet holes, KDMGC does not supply tables, chairs, umbrellas for golf days.
18. Any accounts not settled within 14 days, a default of payment will be listed on ITC.
19. We are not responsible for wet hole setup on golf days, however are glad to assist you!
20. All completed booking sheets must be emailed to operations@kingdavidmowbraygc.co.za
21. Golf Carts to be booked directly with the Pro Shop . We have 20 carts on site during summer! Should you require additional carts to be brought in, this would be at a cost of R450 each.
22. **A mandatory 10% gratuity will apply to all food and beverages.**
23. Shotgun starts will commence at 13h00 and there is a minimum amount of 100 players. There will be an additional green fee of R30 per player.
